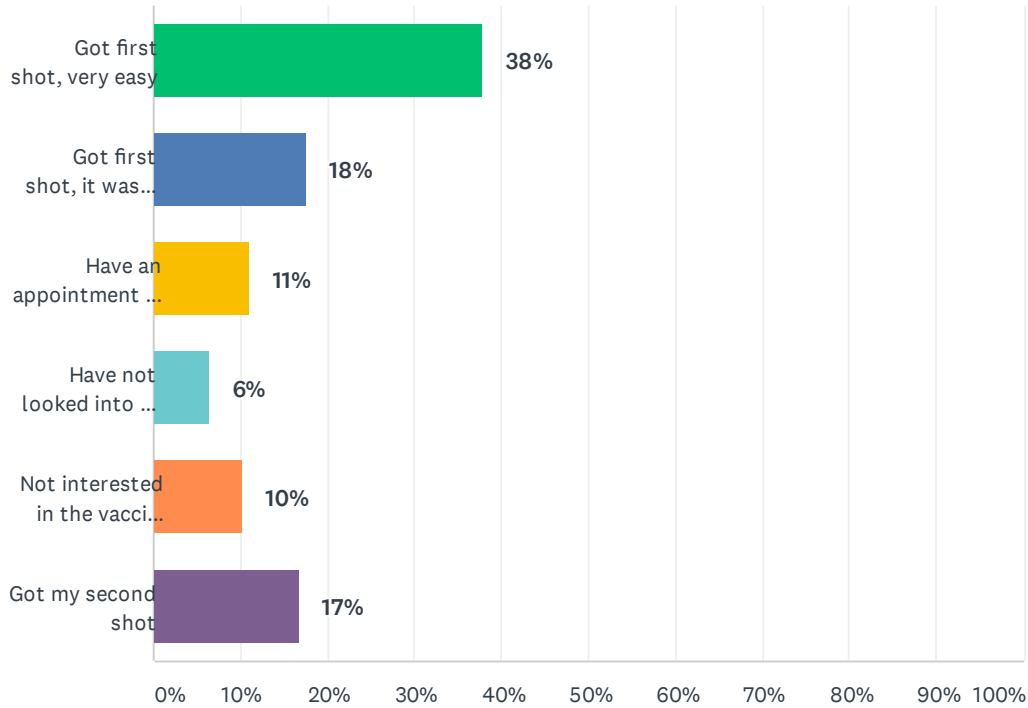


Q1 How has the vaccination process gone for you?

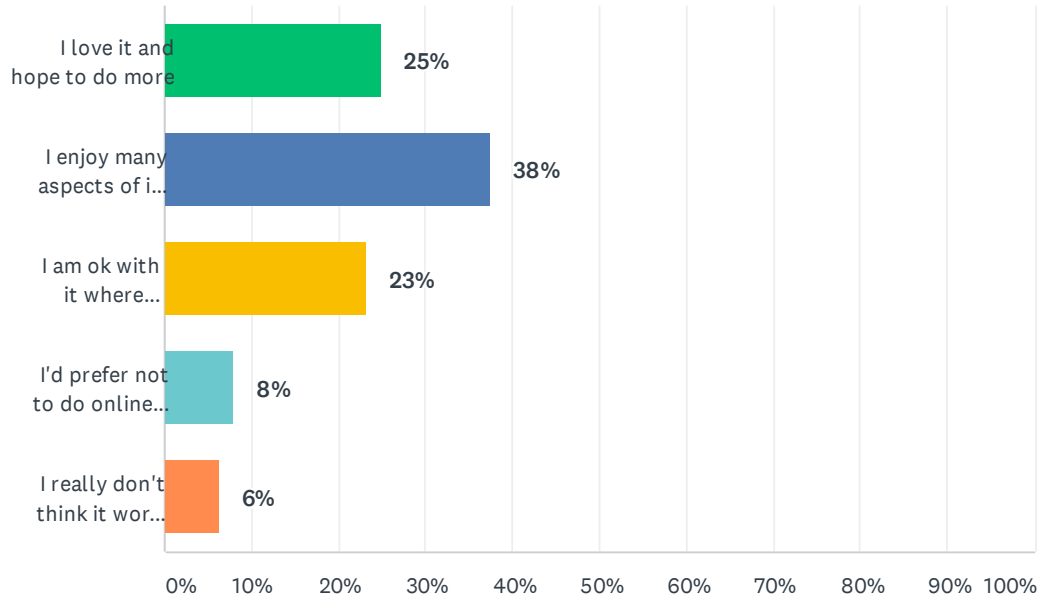

Q2 What are your thoughts on remote services and online education?

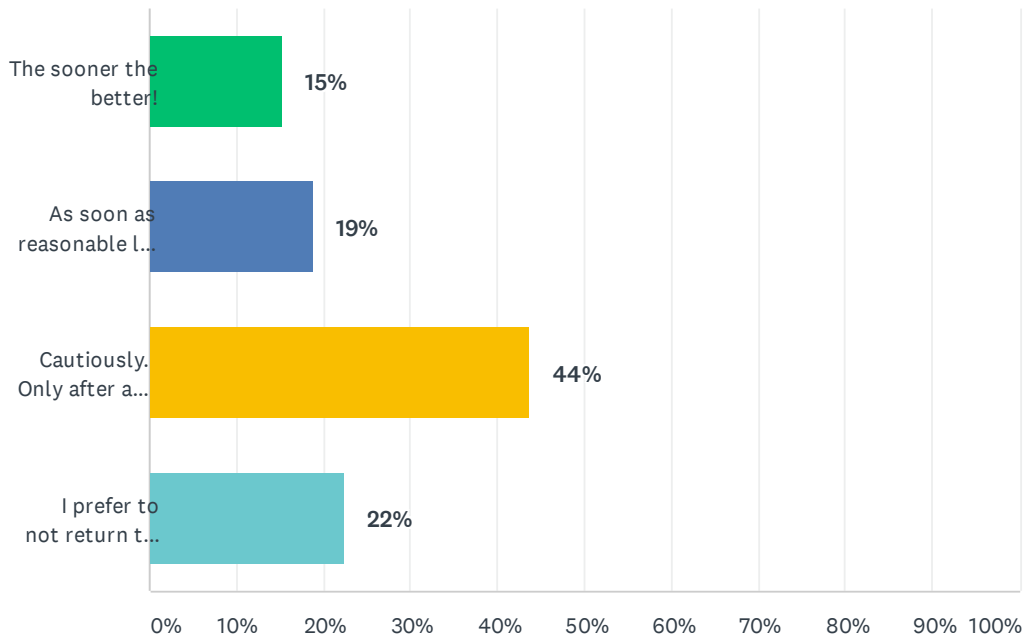
