


Q1 Do you support Citrus requiring proof of vaccination for all employees on campus?



Q2 Do you support Citrus mandating vaccinations for students who come on campus?





Q4 How important is mandatory VACCINATION (recognizing legal exemptions) to you?



Q5 How important is mandatory WEEKLY TESTING for all employees on campus?



Q6 How important is mandatory WEEKLY TESTING for unvaccinated employees?



Q7 How important is mandatory WEEKLY TESTING for faculty?



Q8 How important is mandatory WEEKLY TESTING for students on campus?



Q9 How important is mandatory MASK WEARING when on campus (indoors and outdoors) regardless of vaccination status?



Q10 What is your comfort level returning back to campus in Fall?




